2. Conference Organising Committee


Thank you to Chairman Murray Smith who together with the Local Conference Committee in Whangarei have done a wonderful job in helping to organise this year's Whangarei Conference.

6. Minutes of AGM July 2013

45TH ANNUAL GENERAL MEETING of THE INSTITUTE OF QUARRYING NZ INC held at the Dunedin Town Hall, Dunedin at 2.00 pm on Wednesday 10th July 2013.

The 2013 IOQ Annual General Meeting opened at 2.00 pm.

1. Welcome:

President Gavin Hartley welcomed all attendees to this year's AGM.

2. Present:

Gavin Hartley [Chair], Vice President Gordon Laing, plus 49 members, visitors etc [list attached].

In Attendance: Christine Dodds taking Minutes.

3. Apologies:

Brian Bouzaid, Andrew Robertson, Andrew Dronjak and Terry O'Reilly.

4. Condolences:

Lady Isaac, Murray Cohen and John Fulton.

5. Minutes of Previous AGM:

Minutes of 44th AGM held in Wellington on 11th July 2012 were in the Annual Report.

6. Matters Arising:

There were no matters arising.

7. President's Report:

Gavin Hartley read his Annual Report which covered Board activities over the past year. He stated that each year we need to measure ourselves and in doing this we look at our mission statement. IOQ liaise with the AQA on a number of issues, have an excellent website and a quarterly newsletter. IOQ Executive also maintain a presence on other Boards, have initiated CPD, and attend branch meetings where possible. Membership currently is 216 financial members however last year it was 373 because some members who were not financial were included; lower financial membership numbers as some companies no longer pay for their staff. MITO are now the industry training organisation and they are a leader in terms of qualification completions which has to be good for training people in our industry. The challenge for the future is to keep existing membership and increase new membership plus include invited guests to the IOQ Board.

Gavin Hartley thanked his employer Blackhead Quarries for their support in his role.

8. Financial Accounts 2012:

The audited Financial Accounts for the year ended 31 December 2012 were presented. Expenses were up and income was down so this represented a loss for the year. However this loss was planned for with a copy of "Profiles in Stone" history book given to every member, and changing the IOQNZ Rules was a bigger expense than intended. These two expenses necessitated splitting a term deposit.

Also included in the Annual Report were the audited Conference Accounts which showed a net profit of \$25,000 which was split between the partners.

9. Secretary/Treasurer and Branch Reports:

These reports were taken as read.

10. CPD:

Gordon Laing gave an overview of CPD which has been trialled for the past year. The presentation gave examples of how the online system and the audit process would work.

11. Website:

Murray Discombe gave an overview of navigating the website and how to get into the "members only" section and how to use the CPD section to record professional development. The report finished with web statistics that showed how often the different pages are accessed.

Steve Ellis questioned if MBIE; would recognise this system and what formal audit training the auditors have. The system is live immediately to allow members to record the CPD but not for auditing. Currently this system follows the UK outline. Another query was the lack of direction for Health and Safety which is very important to this industry.

George Kelcher commended the IOQ on getting the CPD up and running.

Both nominees spoke to those present before a vote was taken. After votes were counted Dean was congratulated on being elected to this position. His skills and passion will be appreciated. The votes were then destroyed.

13. General Business:

He was elected Chairman for the Northland Branch last year and is not sure what he should be doing in terms of organising for the conference at local level. Thank you to Martin Hammond and his team for organising this year's conference.



7. President's Annual Report 2014



It's only been a year ago since I was elected as President of the Institute at our 45th AGM held in Dunedin and the past twelve months have certainly seen plenty of activity.

The 45th Annual Conference held in Dunedin last year was very successful. Martin Hammond (Conference Chairman), the Local Conference Committee

and Adrian Mattinson managed to organise not only a great conference, but also the weather to match. This conference was also the venue for the 2013 IOQ International Presidents' Meeting which was attended by;

It was a great honour for me to be asked to deliver the "Address to a Haggis" on the opening night of the Dunedin Conference. It was especially memorable to have all of the International Presidents and Chairman join me on stage to partake of a "wee dram", when everyone raised their glasses in a toast to the haggis. I can honestly say that it was the largest "Haggis Party" that I have ever been part of.

Phil James also delivered the opening keynote address to the delegates at the conference which was well received. At the 2013 AGM there were a few changes to the executive council, with Gavin Hartley taking on a supporting role as Past President, Les Ward elected as the Vice President and Dean Torstonson elected to the executive council. I would particularly like to acknowledge our outgoing Past President, Warwick Leach, for all the work he has done for the executive over the past 11 years.

Congratulations to the recipients of our annual awards given out in Dunedin – the Neimac Award went to Craig Payne (J Swap Quarries), Rocktec Innovation went to George Kelcher (Road Metals), Winstone Aggregate Safety Award went to Kerry Reilly (Baldwins Quarry), RD Hassad Memorial Trophy went to Andrew Dronjak, IOQ NZ Shield went to Warwick Leach, Lyn Jordan Memorial Trophy went to Daniel Leemeyer, Jason Tavioni and Nick Bastow (Redbull Powder Co.).

Also I would like to acknowledge all the nominees for the effort that was put into your entries. I would like to thank all our award sponsors for their continued support and I look forward to announcing this year's award recipients at our conference in Whangarei. This year we also have an additional award - the Porter Equipment Quarry Leadership Award, which is to be presented every second year.

Of particular interest at the conference in Dunedin was the panel discussion on the changes to legislation that will have an impact on our industry, following the recent release of the

Discussion Document on "Safe Mines: safe workers". Our industry came together to provide the majority of the submissions received by the Pike River Implementation Team (PRIT) This was followed by an opportunity to send in a submission to the Government's Transport & Industrial Relations Select Committee which I also presented to in person at Parliament House in early August, 2013. The time and effort put in by everyone into these submissions has resulted in the Quarry Industry's collective voice being heard.

The Quarry Industry Working Group (QIWG) was established in conjunction with Worksafe NZ and has held several meetings over the past eight months. QIWG has been drafting guidelines for the industry that will work well for all quarries and will support best practice in our industry. These guidelines will in turn lead to the Quarry Industry Regulations being established.

This year's conference is being held up in the "Winterless North" in Whangarei (July 16th – 18th). Murray Smith is the conference chairman, who, along with the Local Conference Committee, has managed to put a wide range of speakers together for your interest based on the theme for this year "Our Giants of the North".

In September, together with a strong representation from IOQ NZ, I attended the 56th IQA Conference that was held in Townsville. It was a very packed few days in the heat of the Townsville spring. It started with a very sociable golf day, supported by Hyundai/AIQEF. This was followed by the Hitachi Welcome Reception on the Wednesday evening. Then we were into the conference proper on Thursday, Friday & Saturday morning, with a wide range of topics presented by the speakers. Thursday evening had the Komatsu Conference Dinner and on Friday there was a field trip to the Holcim Quarry (just off the Bruce Highway). In the evening it was the Caterpillar Gala Awards Evening. We finished off with the AIQEF Auction & Lunch on Saturday. There was a most entertaining MC for the conference - our own Steve Davis.

The following awards were presented during the conference in Townsville: Hitachi Hard Hat Award – Richard Tomkins (for contribution to the advancement of OH&S in the quarry industry), Rocktec Innovation Award – Gavin Markwell (contribution to excellence and innovation in the quarry industry), Volvo Travel Award – John Sherburd (contribution toward the advancement of environmental management in the industry), Hyundai Award – Chris Prowse (best technical paper in the quarry industry), Caterpiller Continuous Improvement Award – Brad Doyle (improving and evolving their Australian extractive business through structured and measured continuous improvements in a work related activity), ESCO Young Members Award – Craig Potts (which recognises a young member for their achievements in or their contribution to the extractive industry), Alex Northover award – Todd Kalajzich (best prepared portfolio of evidence submitted to an RTO in support of the applicant seeking accreditation), IQA Service Award – Greg Goodsir & Ian Collins (recognises individuals who have given outstanding service to the IQA & quarrying industry), Hap Seng Fellowship Award – Carlson Daniels (to improve industry links between Australia and Malaysia), Loadrite Lean Processes Award – Alan Seidenkamp (demonstration of a single or on-going application of the "lean principles").

The 2014 Presidents' council meeting was held in Cape Town, with the IQSA being the host nation. During the meeting each nation confirmed progress with regards to the new Technical Member grade for the Institute. Also on the agenda was a discussion on the International Development of the Institute, which appears to be optimistic about its potential as a body of substantial influence on the worldwide quarrying and aggregates industry. Judging of the Caenarfon Award took place with the entry from the UK this year's recipient – "Our People – Our greatest Resource". Finally, there was a brief discussion around the planning for the Institute's Centenary (2017) and what recognition might be appropriate to recognise one hundred years.

This was then followed by a tour to the Lafarge Tygerberg Quarry, about thirty minutes drive from Cape Town's CBD. During the conference itself, the Presidents gave a ten to fifteen minute paper on their country's respective industry issues. I gave an update of where New Zealand is with regards to the Quarry Regulations/Guidelines and an overview of the Institute's CPD programme.

Once the conference was finished our hosts took us on an action packed day to the main attractions in Cape Town, Table Mountain and a trip to Robben Island. We travelled on one of the original prisoners' ships and spent several hours being shown round the island and a guided tour of the prison itself. This included being able to look into Nelson Mandela's actual prison cell, where he spent his first eighteen years of imprisonment. For me personally the most poignant part of the tour was the lime quarry where the prisoners were taken to break rocks during their incarceration. At the entrance to the quarry there is a small pile of rocks. In 1995 there was a reunion of all political prisoners from the apartheid era held on the Island. As he was leaving the quarry, Nelson Mandela started the heap by picking up a small stone and walking forward with it and placing it on the ground. With no word spoken, all of the others followed suit and they created the memorial cairn of stones at the quarry entrance (see below).

The executive council has met four times during the past twelve months. Once in Wellington, then Whangarei, and two board meetings have been held in Auckland. I have also managed to attend a Northland and a Waikato/Bay of Plenty branch meeting during the past year.

Christine Dodds, our Secretary/Treasurer, stood down at the end of February this year after nine years to become the IOQ NZ (Inc.)'s longest serving Secretary/Treasurer. Our sincere thanks and appreciation for all Christine has done for the Institute.

I am pleased to welcome Petrina Torstonson into the role of Secretary/Treasurer from 1 April 2014. Petrina has previously worked for Local Government in a number of financial roles over the past 14 years and is currently based in Paeroa. I trust you will all welcome Petrina to the new position and introduce yourself at this year's conference.

The training organisation, MITO, has now elected an Extractive Industry Governance Group for the TRoQ for the industry and they are currently working to streamline the wide range of qualifications available in the extractive industry. Also, I would like to acknowledge Brian Bouzaid and Bruce Taylor, who have represented the industry on the MITO Board during the past year.

Information received from our website has shown that to date there has not been a great take up of the IOQ NZ's Continuing Professional Development (CPD) on-line programme, which was launched last year at the AGM in Dunedin. All current members can access this through the members' log-in section of the IOQ NZ website. I would like to recommend to our current members that they take advantage of our CPD programme, as it is not a question of "if we need to do it", but "when we will need to do it". Each member who registers will also receive a hard copy document that can be used to collate all the evidence to support the member's CPD hours.

The Jim Macdonald Lecture Tour has just recently finished, with each branch organising a venue for our guest speaker, Tony Forster (Chief Inspector – Extractives). Listening to the feedback from around the country, Tony's presentations were very well received and the attendance numbers would indicate that a great number from our industry were interested in hearing what Tony had to say. I would like to acknowledge the generous support that IOQ NZ (Inc.) received from MIMICO and Metso Minerals, without which we would not be able to have such a high profile speaker available to talk to our members. Our thanks, also to Tony, who gave us his valuable time for this lecture tour. During his tour of the country, he also managed to judge the nominees for the IOQ NZ (Inc.)'s Winstone Aggregate Safety Award, as he travelled around the country.

Thank you to all those sponsors and supporters of the IOQ NZ (Inc.), both nationally and locally, who have made not only our national conference, but also the local branch meetings the success that they have been over the past twelve months.

I would like to acknowledge the support and guidance that I have received over the past twelve months from the IOQ NZ (Inc.) executive council and for the time and effort that they have all put in to help keep our Institute running. Also, my thanks to those from the executive council and Warwick Leach, who have represented the Institute on a number of other industry groups during the past twelve months.



8. Secretary/Treasurer's Report

The 2014 Conference is well and truly here and I am sure that Whangarei will be as enjoyable as all the previous conferences I have attended. Personally, this year will be a much busier time in my new role as Secretary/Treasurer. It is always refreshing to have new challenges ahead and I look forward to working with you all and gaining a sound understanding of the Institute of Quarrying and its role within the Industry.

Firstly, I would like to thank Christine Dodds for all her hard work over the past 9 years. I am sure you will agree that Christine's passion for the industry has contributed positively to the future of the Institute.

Over the past 12 months, we have held four Executive meetings with the first being held in September [Wellington], November [Whangarei], and February and May [Auckland]. The Executive Team have agreed to meet in Auckland for the majority of meetings throughout the year as many Board members are from the Auckland & Waikato/BOP region. This will help reduce our travel expenses, although it will still be necessary to attend some meetings around the country particularly where there needs to be joint industry meetings, AQA meetings etc. The Executive are also looking at using Teleconference Calls (where applicable) to also help keep travel costs down.

In January 2014 the membership invoices were sent out and a number of reminders issued. To date, we have 238 paid financial members with many payments still being received. We are also continually updating our database with new contact details and will over the next few months ask IOQ Executive members and Branches to review members contact details where these appear to be obsolete. This will enable us to update our database and ensure only current members are displayed and avoid unnecessary paperwork in January of each year.

Early in the New Year, the Institute of Quarrying also transferred all of its banking requirements to the Bank of New Zealand which has proved very successful with an excellent banking manager working alongside us providing support when required. The main reason behind the transfer was the poor performance of the ANZ and little support available. As a result, we have now transferred the majority of investments (except one which matures on 18 July 2014) to the Bank of New Zealand which have staggered maturity dates to ensure we have available funds when required.

The quarterly newsletters have continued to be issued throughout the year with our most recent issue in A reminder email is sent out approximately 3-4 weeks prior to each publication requesting articles to be forwarded so if you feel that you are able to contribute – we can place your name onto this mailing list.

Lastly, our Friends of the IOQ have once again been very supportive this year. I am pleased to announce that we have a total of 8 Friends of the IOQ for 2014 which includes two new companies, T R Industries and Crushing & Mining Services. Once again, thank you for your support of the Institute of Quarrying and its valued members.

I look forward to meeting with you all at some stage during the conference. Please feel free to introduce yourself to me as I would be happy to put a name to a face. As my husband recently said "You will probably know more people than I will by the end of the week".

1. Statement of Accounting Policies

Reporting Entity

The Institute Of Quarrying New Zealand Incorporated is a society incorporated under the Incorporated Societies Act,1908.

These financial statements are a general purpose financial report.

These financial statements are for the Institute of Quarrying New Zealand Incorporated only and do not include the financial results of the branches as the Board do not exercise control over their activities.

Measurement Base

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on a historical cost basis are followed by this entity. Accrual accounting is used to match expenses and revenues. Reliance is placed on the fact that this entity is a going concern.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied:

Subscription and sponsorship income is recognised on a cash basis.

Interest income is recognised as it is earned.

Website development costs have been expensed as incurred during the year.

Accounts receivable are stated at their estimated realisable value.

Transactions in foreign currency have been converted at the New Zealand rate of exchange ruling at the date of the transaction.

Investments shown on the Statement of Financial Position are stated inclusive of accrued interest as at balance date. Maturity periods of the investments are less than 12 months but the investments are being held for periods longer than 12 months.

The Statement of Financial Performance has been prepared so that all components are stated net of Goods and Services Tax. All items in the Statement of Financial Position are stated net of Goods and Services Tax, with the exception of receivables and payables, which include Goods and Services Tax.
