2. Conference Organising Committee



6. Minutes of AGM July 2014

46TH ANNUAL GENERAL MEETING of THE INSTITUTE OF QUARRYING NZ INC held at the Forum North Auditorium, Captaine Bougainville Theatre, Whangarei at 2.00 pm on Wednesday 16th July 2014.

The 2014 IOQ Annual General Meeting opened at 2.05 pm.

1. Welcome:

President Gordon Laing welcomed all attendees to this year's AGM.

Present:

Gordon Laing [Chair], Vice President Les Ward, plus 45 attendees etc [list attached] and Petrina Torstonson taking Minutes.

3. Apologies:

Lee Brightwell, Chris Sinclair, Ron J King, Andrew Mahan, Darcy Maddern, Graeme McClymont, Brian McNaulty, Matthew Webster

4. Condolences:

Lubo Joseph Yelavich (known as Wally). Les Ward also acknowledged Darcy Maddern's partner, Gillian and Harry Toa's wife, Karen. A moment of silence was held for those that had passed away in the past 12 months.

5. Minutes of Previous AGM:

Minutes of 45th AGM held in Dunedin on 10th July 2013 were in the Annual Report.

A Loader/A Robertson: Moved that the Minutes of the 45th AGM be accepted as a true and correct record
Carried.

6. Matters Arising:

There were no matters arising.

7. President's Report:

The President's report was printed in the Annual Report and has been taken as read. Gordon Laing read out the highlights.

8. Financial Accounts 2013:

The draft Financial Accounts for the year ended 31 December 2013 were presented in the Annual report.

Gordon Laing read out the Auditors report from Ashton Wheelans (which was received after the Annual Report was printed).

• Andy Loader/Gavin Hartley: Moved that the IOQ Audited 2013 Financial Accounts be adopted...............Carried.

The draft QuarryNZ accounts were also presented in the Annual report. These accounts were awaiting an Auditor's report and therefore, could not be adopted at the AGM.

10. Continuing Professional Development:

G Laing/M Discombe: Moved that the Technical Member grade of the Institute of Quarrying be accepted into the corporate grade of membership for the Institute of Quarrying NZ. There were no objections and the motion was passed unanimously.

13. Website report:

Murray Discombe provided an overview of some aspects of the website and was encouraged that members are continuing to use the website for a source of information particularly around July of each year with up and coming conferences, and key items of interest for the industry.

14. Branch reports:

These reports were taken as read.

A promotional video for the Hamilton Conference will be presented on the Awards night (Friday).



17. General Business:

2014 Membership Card

Tony Carpenter outlined a new benefit available to IOQ members. Membership cards will now be issued to all current financial members and will entitle members to discounts between 10-60% with various suppliers. A flier is available to all members providing details of the discounts. Members who have not paid will be entitled to their discount card once membership fees have been paid. These cards will be mailed out upon receipt of payment.

The membership cards will be renewed each year and therefore, a new card will be issued when memberships are renewed in 2015. The number on the card is allocated permanently to each member year on year. Murray Discombe raised the question whether or not Honorary Fellows and retired members can receive the card. Confirmed yes they will.



Extractive Advisory Group

Tony Hunter advised that WorkSafe have set up an Extractive Advisory Group (EAG) of which he has been appointed to the group. The advisory group has been set up to provide advice to the WorkSafe Board on the effectiveness of the new regulations, specific aspects of the regime, health & safety aspects of the industry etc.

The Extractive Advisory Group is a go between the WorkSafe board and the industry. A meeting of the EAG was held on 3-4 July – where they formed a constitution.

There was much discussion from the floor around ensuring that the COC's are not set too high otherwise staff might find it hard to achieve. Andy Loader confirmed that everybody will be part of a consultation process going forward. George Kelcher said it was very important that we adequate time to be able to consult on these documents. Cunningham encouraged older members of the IOQ to mentor new members.

7. President's Annual Report 2015

Another year has passed since we had a very successful 46th Annual Conference held in Whangarei. Murray Smith (Conference Chairman), the Local Conference Committee and Malcolm Blakely (ICM) - the conference organiser -managed to arrange a great conference. However, with some rather inclement weather in the week leading up to the conference it meant that they had to reorganise part of the conference programme at extremely short notice.



The opening day address from Hon Simon Bridges, Minister of Energy and Resources, Minister of Labour, and Associate Minister for Climate Change Issues discussed a range of quarrying and industry related issues. This was followed by an impressive show at the afternoon field trip to Dicksons Glenbervie Quarry, including a live blast and equipment demonstration. The live blast was probably a first at a conference field trip. The Friday session included a key note address from Dr. Susan Tighe, P.Eng, Canada Research Chair, Norman W. McLeod Professor of Sustainable Pavement Engineering, Director Centre for Pavement and Transporation Technology and Professor of Civil and Environmental Engineering, University of Waterloo, about "Recycling: Why Not? What are you waiting for?"

Congratulations to the recipients of our annual awards given out at Whangarei and all the other nominees for the effort that was put into your entries – the Neimac Award went to Joanne Dickson (Dicksons Transport and Quarries, Glenbervie Quarry), Rocktec Innovation went to Gordon Skeggs (Southern Aggregates), Winstone Aggregate Safety Award went to Johnny Dickson and his team at Glenbervie Quarry, RD Hassed Memorial Trophy went to Rob Smith, Lyn Jordan Memorial Trophy went to George Kelcher (Road Metals) and there were two recipients of the Webster Scholarship for 2014, Shawn McLean and Andrew Dronjak. Last year we had an additional award - the Porter Equipment Quarry Leadership Award, and Steve Ellis (Stevensons) was the inaugural recipient, which was presented to Steve at the Porter Group Lunch.

At the 2014 AGM there was a change in the executive, with Selwyn Dodd coming on board. During the past year there have been a couple of changes within the executive, with Chris Sinclair and Andrew Mahan resigning. This resulted in both Darcy Maddern and Gavin Parker being co-opted onto the executive as replacements for Chris and Andrew. I would like to acknowledge the commitment from Darcy as he took on the IOQ NZ (Inc.)'s position on the MITO Extractive Industry Governance Group.

During the past twelve months there have been two items for consultation that will have an influence on our industry. Firstly there was the "Best Practice Guidelines – Health and Safety at Surface Mines, Alluvial Mines and Quarries". This was followed by the "Proposed Extractive Industry Certificate of Competence Requirements", which clearly struck a chord with the quarry sector with thirty-one of the forty-two submissions made to WorkSafe NZ from our industry.

As part of the renewal process for the Certificates of Competence (CoC), all holders are required to have Continuing Professional Development (CPD). The IOQ NZ (Inc.) has had its CPD facility through the members' log-in section of the IOQ NZ website available to the members for some time. It has been a slow take up on this, despite reminders that it will be a compulsory requirement to all CoC holders to have their CPD for their CoC renewal from the beginning of 2016.

A few members from the IOQ NZ (Inc.) executive, including Paul Sutton (IQA), were given the opportunity to present our CPD programme to a representative from WorkSafe in April. IOQ NZ (Inc.) will keep you all posted on any developments regarding the CPD component for your CoC renewal as is becomes available.

I would like to remind everyone that if you have any questions about your CoC renewal, as 2016 rapidly approaches, then you should be making contact with WorkSafe, who will give you all the answers that you need to ensure that you meet the requirements to renew your relevant CoC. Also, as you will be aware, there are additional unit standards that all CoC holders need to complete to be able to renew their CoC from the beginning of 2016. As the dates for these additional unit standards are released, they are announced through the IOQ NZ (Inc.)'s website, including all the contact details for your enquiry. We trust you find this useful and can use this to make arrangements to attend the relevant courses to ensure that your CoCs will be reissued.

During the past twelve months there has been no Presidents' council meeting, as it is due to be held in Malaysia in October this year. However, during this time there have been three Presidents' Council teleconferences, which have helped to maintain the progress of the links between the international institutes.

I would like to acknowledge Bruce Taylor, who has represented the industry on the MITO Board during the past year and Tony Hunter, General Manager Blackhead Quarries who has served as the quarry industry's representative on the Extractive Industry Advisory Group to WorkSafe NZ Board. Also, congratulations to Dean Torstonson, Steve Ellis and Andy Loader on their appointment to the New Zealand Mining Board of Examiners.

During the past six months there have been three fatalities in the quarry industry. Our thoughts go out to all those who have been affected, whether directly or indirectly.

Thank you to all those sponsors and supporters of the IOQ NZ (Inc.), both nationally and locally, who have made not only our national conference, but also the local branch meetings the success that they have been over the past twelve months.

The IOQ NZ (Inc.) has several companies who support the Institute through its Friends of the IOQ" programme. These are – Advanced Engineering, Crushing & Mining Supplies, Locker Group, MIMICO, Real Steel, Rocktec, Russet Engineering, TR Industries and our latest "Friend" Oil Imports Ltd. Also, the IOQ NZ (Inc.) is generously supported by the Webster Group and Vickers Quarries on an ongoing basis.

As my term of office as President is coming to a close, I would like to take this opportunity to acknowledge the support and guidance that I have received over the past twelve months from the IOQ NZ (Inc.) executive council and for the time and effort that they have all put in to help keep our Institute running. Once again I would like to thank those from the executive council and industry, who have represented the Institute on a number of industry groups during the past twelve months.

This year's conference is being held in the heart of the Waikato in Hamilton (July 15th – 17th). Allan McDonald is the conference chairman, who, together with the Local Conference Committee, has managed to put a wide range of speakers together for your interest based on the theme for this year "Forging the Path to the Future".

I also wish to acknowledge my place of work, Ihumatao Quarries Ltd, for its support in allowing me to carry out my role as President of the Institute of Quarrying New Zealand (Inc.).

Finally, to my wife Karen, who once again, has been a rock to lean on during my second year as your President, thank you for your support.

8. Secretary/Treasurer's Report

It has now been over 12 months since I was employed as the Secretary/Treasurer for the Institute of Quarrying NZ (Inc.).

It has been an enjoyable year working with the Executive Team and it truly is worth noting the hard work that each and every Executive member puts into their role on the Board and without their support a number of goals would not have been achieved.

Over the past year, we have held four Executive meetings - September [Auckland], November [Hamilton] and February and May [Auckland]. In each meeting, the agenda has been full, with many topics discussed including updates around the Work Safe notifications and legislative requirements which are currently challenging our Industry. More recently, we have resurrected the joint meetings with the Aggregates and Quarry Association prior to commencing our IOQ meeting to ensure we have a combined voice on health and safety matters.

As at 30 June 2015, the Institute of Quarrying NZ had a total of 294 paid financial members for 2015. It is encouraging to see an increased number of membership applications being received particularly in the Northland area however all other regions still remain active. The discount card introduced at the last conference is also working well with a number of members reporting to have received good discounts.

I am also pleased to advice that we have a total of 9 Friends of the IOQ supporting our Industry with Oil Imports Ltd recently signing up for 2015. We would like to thank you all for your support and encourage you to continually use the IOQ newsletter to publish any articles or advertisements.

During the past 12 months, we have achieved a number of goals in relation to the administration of the Institute. The main achievements include:

- A review of our IOQ Database which was signalled at our last AGM. We identified that there were a number of non-financial members in the database which results in unnecessary paperwork each year with very little reward. Many of these non-financial members have either moved on from the Industry, moved overseas, or no longer have the need to be a member of the Institute. It was agreed by the Executive to remove these members in accordance with the IOQNZ rules, as approved at our meeting on 19 November 2014.
- A number of procedures have been approved to streamline our administration processes. approved procedures state the main purpose, responsibilities and a step by step guideline as to how to complete each job. To date, the approved procedures are as follows and will be reviewed every two years:



9. Financial Accounts 2014

Institute of Quarrying of New Zealand Incorporated Notes to the Accounts For the Year Ended 31 December 2014

1. Statement of Accounting Policies

Reporting Entity

The Institute of Quarrying New Zealand Incorporated is a society incorporated under the Incorporated Societies Act, 1908.

These financial statements are a general purpose financial report.

These financial statements are for the Institute of Quarrying New Zealand Incorporated only and do not include the financial results of the branches as the Board do not exercise control over their activities.

Measurement Base

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on a historical cost basis are followed by this entity. Accrual accounting is used to match revenues and expenses. Reliance is placed on the fact that the entity is a going concern.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of financial performance and position have been applied:

Subscription and sponsorship income is recognised on a cash basis.

Interest income is recognised as it is earned.

Website development costs have been expensed as incurred during the year.

Accounts receivable are stated at their estimated value.

Transactions in foreign currency have been converted at the New Zealand rate of exchange ruling at the date of the transaction.

Investments shown on the Statement of Financial Position are stated inclusive of accrued interest as at balance date. Maturity periods of the investments are less than 12 months but the investments are being held for periods longer than 12 months.

The Statement of Financial Performance has been prepared so that all components are stated net of Goods and Services Tax. All items in the Statement of Financial Position are stated net of Goods and Services Tax, with the exception of receivables and payables, which include Goods and Services Tax.





INDEPENDENT AUDITOR'S REPORT

To the Members of Institute of Quarrying of New Zealand Inc.

We have audited the financial statements of Institute of Quarrying of New Zealand Inc. on pages 1 to 7, which comprise the statement of financial position as at 31 December 2014, and the statement of financial performance, the statements of movements in members funds and Education Trust Reserve for the year then ended, and the notes to the financial statements that includes a statement of accounting policies and other explanatory information.

Executive Committee's Responsibility for the Financial Statements

The Executive Committee is responsible for the preparation and fair presentation of these financial statements in accordance with generally accepted accounting practice in New Zealand and for such internal controls as the Executive Committee determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with International Standards on Auditing (New Zealand). These standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Other than in our capacity as auditor we have no relationship with, or interests in, Institute of Quarrying of New Zealand Inc.

Basis for Qualified Opinion

As reported in Note 5 the financial statements for the Joint Conference Account for the year ending 30 September 2014 have not yet been audited. The Institute of Quarrying of New Zealand Incorporated has recognised its share of the surplus and equity based on draft accounts. We are unable to obtain sufficient appropriate audit evidence on these balances conference revenue \$33,716 (income) and joint conference account \$79,868 (non-current assets) as they had not been audited at the time of issuing our audit report. Consequently, we are unable to determine whether any adjustments to these amounts were necessary.

Qualified Opinion

In our opinion, except for the possible effects of the matter described in the Basis of Qualified Opinion paragraph, the financial statements on 1 to 7 present fairly, in all material respects, the financial position of the Institute of Quarrying of New Zealand Inc. as at 31 December 2014 and its financial performance for the year then ended in accordance with generally accepted accounting practice in New Zealand.
