Presidents Report

Welcome to the Spring newsletter.

After a tough winter it is great to see the days getting longer with everyone's spirits starting to lift and looking forward to Summer. It has certainly been a busy few months with the QuarryNZ Conference setting new attendance records and the conference programmes continuing to deliver high quality relevant The proof of the success of the conference was also highlighted by the comments from our international guests who could not believe how a country with such a small population and industry could achieve the attendance levels we did and run such a professional conference. Thanks to the AQA for encouraging these guests to stay on and give us insight to some of the international issues. It was interesting to hear how they had regulations and standards set across numerous countries and governments with a common goal. So maybe there is still hope yet for us to get our own consenting and planning processes sorted.

A big thanks to conference organisers who continue to raise the bar and to our supporters who make this all possible. I encourage you to support these suppliers where possible.

The CoC review has been the centre of conversation for many in the industry. For various reasons what should have been a straight forward review to make subtle changes certainly got complicated. You can read more about this in Paul Hunt's article. It is also worth noting the amount of work done behind the scenes by organisations and individuals who put in submissions and gave their time make sure industry had an opportunity to be heard. IOQ NZ (Inc.) and AQA worked together to make sure industries concerns were acknowledged while representing our individual organisations. There is some irony to the changes and extra units now required.

There has always been the argument that the CoC did not teach all of the subjects to make a Quarry Manager. So maybe we are getting there albeit by default.

We have representatives on the working group with Hanga-Aro-Rau and Te Pukenga looking at the implementation of the new qualification frame work. One intention of the change is to deliver flexible training models including regional workplace learning and There are some promising assessment. changes being proposed with Micro learning credentials. This allows for small packages of learning made up of a limited number of units to be put together to make a qualification. These can then be combined to achieve something like the CoC qualification. expected, there are some issues to be worked through. There are questions regarding the delivery of training and how this will be achieved in the workplace. There are also concerns that access to training material is being restricted. IOQ NZ (Inc.) and AQA have formally raised the issue and are working with Hanga Aro Rau and Te Pukenga to find a If you do have issues with resolution. accessing training, please bring it to our attention.

Paul Sutton has been working on our funding projects with training modules being written and research programme underway. Thank you for those who are taking part in the research.

It has been interesting to observe the response following the floods in Napier and Gisborne. The talk of rebuilding of infrastructure and resilience has been front and centre with some very large numbers being indicated in regards to investment dollars and volume

of aggregate required. One of the positive outcomes has been the engagement from the Napier Regional Council.





Presidents Report cont

There have been several meetings with industry regarding the availability of aggregate and how to identify what material is available and where it is located. One of the key points raised was that there is a need to get accurate information for all of the river systems to ensure these requirements can be met while protecting supply for existing demand. It is important we take these opportunities to make our case heard.

In closing it is always good to take a moment to remember what we have achieved. We are producing more product with less staff to specifications and considerably increased controls and restrictions across all of our operations. It is important we recognise the implications of meeting these demands both in production and staff. Quarry certificate issued by the mines department in the 1940s reads safety is the first consideration and the regulations in the 1950s written on cloth states vigilance is the price we pay for safety. So, let's look after our staff and ourselves.

Auckland Branch Report

In the last few months, Auckland Branch have covered off our AGM as well as a technical evening, each generously hosted by a local supplier to our industry.

In June our AGM was held at TDX's yard in Wiri, where we held election of officers for Chair and Secretary. This year the successful candidates elected to these positions were Lance Gosling and Aaron Graham, respectively. The existing committee members were re-elected, with the exception of Luke Balsillie who did not stand again.

TDX gave us an introduction to Volvo's innovation in machine management. This gives the ability for the OEM to monitor various machine operating parameters, reporting back to the local service agent, giving them a better understanding of what has faulted on a machine prior to going to site to check the machine in person, which provides better efficiencies and a timelier manner of repair.

After the AGM we were fortunate to have Paul Hunt talking on his perceptions of the quarrying industry and areas WorkSafe would be focusing on moving forward, after the latest round of new regulations were to come into effect in July. He updated us on the CoC changes, especially defining A and B Grade operations and the changes of new unit standards that would be relevant when applying for new CoCs. He said the recent workshops that WorkSafe had conducted around the country had been very successful, for providing a better understanding of safety management systems required for those operating B Grade quarries, to ensure they comply with the new standards. Paul said WorkSafe's focus would be to continue educating operators on their expectations but there would come a time when stronger enforcement would be needed to ensure satisfactory compliance by all operators across the sector.

In August we held a technical evening focusing on health & safety, where we were hosted by Athenry Electrical. Presentations were given by Adam Kane, NHP Electrical Engineering Products NZ, on machinery guarding and safety standards. We also had Satendra Deo, Schneider Electric Australia and Ricky Holton, Schneider New Zealand, talking on arc flash dangers and controls, especially relevant to our industry in electrical cabinets and motor controls. We were fortunate Ricky had organised for Satendra to come over from Australia specially for our event which we were very grateful for. Stuart Heslop, WorkSafe Inspector, gave a more in-depth update of recent regulation changes. Stuart said there had been a positive uptake of evidence gathering for the new requirements of quarry operations for site and machinery checks and documenting of principle site hazards and they were willing to help get operators up to speed with the new requirements.



We are looking forward to our annual social event, go kart racing in September and have a full contingent of teams of quarries and suppliers taking part. In October we are heading to Stevenson Aggregates' Drury Quarry for a site tour and in November we will have our Jim Macdonald Tour event sponsored by Metso and MIMICO with Tegan Smith to present on changing quarrying perceptions. This event was cancelled earlier in the year, so we are pleased to have Tegan available to present to Auckland Branch while she is in New Zealand.

ConCove Funding: Institute of Quarrying New Zealand's Futures Research Project

The IOQ NZ has been successful in securing funding from ConCove to conduct a Futures Research Project. The project's aim is to predict the trends that will impact the quarrying industry in New Zealand with the view to guide quarrying practice, inform vocational education, and strategic policy directions across our government, Hanga-Ara-Rau, the quarrying industry and its suppliers and stakeholders.

The purpose of the Institute of Quarrying New Zealand's Futures Research Project is to answer the following questions:

- 1. What are the **possible futures** of the New Zealand Industry by 2030?
- 2. What are the **drivers of the future** that will impact the future of the New Zealand Quarrying Industry by 2030?
- 3. What **strategies** must be developed and actioned by the industry bodies and regulators to address these drivers by 2030?

The research will explore how previous trends have evolved and impacted on the quarrying industry as well as the new trends, impacts and drivers that have emerged (or are predicted to emerge), providing a perspective around how these trends may unfold in the coming decades. These trends will inform the evaluation of current vocational education/continuing professional development training programmes and the development of new vocational education/continuing professional development training programmes.

The outcomes of this research will investigate different scenarios from doing nothing to implementing strategies developed to address the drivers identified. It is hoped that this research will provide sufficient data to leaders in the industry to make the required changes to make the industry sustainable.

The final report will be completed in early 2024.

Inspiring Futures Foundation (IFF) Funding: Institute of Quarrying New Zealand Course Development and Facilitation

The IOQ NZ has been successful in securing funding from the IFF to develop and facilitate the following courses:

- 1. Worker Health
- 2. Emergency Management
- 3. Extractive Planning
- 4. Quarry Consenting
- 5. Safety Management System

Course development will be finalised in early 2024 with facilitations rolling out soon after.

BOE Update

Industry CoC update:

Applicants for new CoCs from July 18th, 2023, must now meet the prescribed competencies that were posted by WorkSafe in July in a Safe Work Instrument (SWI). This SWI can be found on the WorkSafe web pages. The new requirements include some additional unit standards for Certificates of Competence (CoC's).

The unit standards that have been added were consulted on with stakeholders prior to the SWI being posted.

During consultation there were submissions received asking what transitional arrangements could be put in place. The BoE determined that there were no easy transitional arrangements that could be included in the SWI to transition from the pre-July 18th regime to new SWI current regime. Therefore, the BoE considered the availability of all the new unit standards that they believed should be included and decided to only post in the first SWI the new unit standards that would be available immediately. (Or would be available within a few weeks of the change being implemented). The introduction of other new unit standards that were not immediately available has been delayed until next year when the

It is known that there has been some confusion over some of the requirements or availability of units from training organisation.

SWI will be again consulted on

and then updated.

The BoE appreciate that the changes may require some potential applicants for a CoC to delay their applications until they have completed the additional unit standards now required.

Mining Board of Examiners

The BoE believe that the short -term issues will quickly be resolved as training providers and applicants adjust to the updated requirements.

There was a significant increase in applications for CoC's prior to introduction of the SWI in mid -July. This was good evidence that most persons in Industry understood the requirements were coming, and ensured they got their applications into the BoE prior to the change being implemented. All applications received prior to July 18th, 2023, have been processed under the old criteria.

Those that did not get applications in prior to July 18^{th} , 2023, will have to complete all of the new requirements before applying for a noral examination. There are no easy options for the BoE to grant exceptions to this.

Mining Operations and Quarrying Operations - Safe Work Instrument | WorkSafe

Continuous Professional Development General update: Recently several applicants for renewal of Certificates of Competence have claimed a WorkSafe Inspectors visit as continuous professional development (CPD). The BoE have discussed this issue and in general do not see that the visit of an Inspector meets the criteria for CPD. Claiming CPD for the period of time an inspector visited is considered to be inappropriate.

Note: Workshops or seminars run by WorkSafe inspectors are valid CPD.

The time the attendee can claim will be stated by WorkSafe at the sessions.

BoE member selection: Applicants for BoE members will be sought over Sept and as this process is undertaken it is considered that explanation of the responsibilities and membership of the board of examiners would be a useful reminder to Industry.

The Board of Examiners functions and makeup is stated in the Health and Safety act as follows.

28 Functions of Board
The functions of the Board
are—

- (a) to advise WorkSafe on competency requirements for mine workers:
- (b) to examine applicants, or have applicants examined, for certificates of competence:
- (c) to issue, renew, cancel, and suspend certificates of competence:
- (d) any other function relating to training and competency requirements for participants in the extractives industry conferred on the Board by regulations made under this Act.

29 Membership of Board

- (I) WorkSafe may at any time appoint a member of the Board.
- (2) The appointment of a member of the Board must be for a specified period.
- (3) WorkSafe must appoint one of the members of the Board as the chairperson of the Board.
- (4) When appointing a member of the Board, WorkSafe must have regard to the need to ensure that the Board has

- (5) Without limiting subclause (4), the Board may include I or more employees of WorkSafe.

The process for selecting the board members is usually undertaken by a panel which includes independent persons from Industry. They are required to ensure that as well as selecting suitable board members, that the board has the appropriate mix of members as required in the Act.

Board members normally have a three-year term and are then obliged to reapply at the end of the term if they wish to continue to be on the Board of Examiners. Many members do choose to reapply, and this is appreciated, as the experience that members bring in their subsequent terms improves the function of the board.

The board members work very hard on behalf of Industry, with the last two years being unusually busy with several of the regulation changes requiring the Board to make changes to CoC's and replace the old gazette notices with a Safe Work Instrument.





MinEx Update

MinEx is putting the final touches to a briefing on the extractives sector and health and safety for the incoming Government. We will be encouraging engagement with MinEx in extractives policy development, better funding and/or alternative funding for the High Hazard Unit in WorkSafe, additional resourcing to assist small mines and quarries, and a review of funding for the Mines Rescue Service.

During September we are about to embark on the Te Waharoa programme which is a partnership between the extractives sector, MITO/Te Pūkenga, and Waikato Tainui. This I0-week programme in the Waikato will involve some cultural and work ready training for young unemployed for 4 weeks, and 6 weeks paid work experience. We currently have placed 8 young people in the programme thanks to Bathurst Resources, J Swap Contractors, Winstone Aggregates and Stevenson Aggregates who will be hosting the work experience.

We continue to work on the review of qualifications with our Workforce Development Council, Hanga-Aro-Rau, with proposed micro-credentials currently being developed. These will allow learners to build up to a qualification in small credentials including completing their CoC if they wish.

We have almost completed our MinEx workshops for 2023. We are again being assisted with delivery by WorkSafe inspectors. Keep an eye on our Train Brain newsletters or visit the MinEx website for details. www.minex.org.nz




