

QuarryNZ Conference 2013

The memories are now fading of Wellington and plans are well underway for Dunedin 10 - 12 July 2013. There have been some minor changes with how our conference is managed. In September the organisation of our QuarryNZ conference was put out to tender. Four tenders were received and one year contracts were awarded to Adrian Mattinson Consulting (Conference organization) and AES (Christine Dodds) for Conference Financial Services. For our members it is business as usual, the local conference committee along with Adrian, have had a number of meetings and plan to entertain all with southern hospitality. The format will be similar to previous years with technical presentations on Thursday and Friday mornings, a Field trip to Blackhead Quarry on Thursday afternoon, the spectacular social events and awards dinner on the Friday night. Next year is quite special as the conference is also hosting the IoQ International Presidents meeting. The Otago/Southland Branch local committee is being led by Martin Hammond our conference chairman, details will be out in the new year. EXITO

As some of you would be aware there have been some changes within the structure of our Training Industry Organisation [EXITO]. A TEC suggested initiative has led to the merger of EXITO with MITO (NZ Motor Industry Training Organisation). I would like to take this opportunity to thank three of our members -Brian Bouzaid, Bruce Taylor and Gordon Laing, for all their efforts over these very trying times. They have acted in EXITO's best interest and ensured the extractive industry continues to have a voice within the board of MITO. EXITO have been allocated two positions on the MITO board and Brian and Bruce have filled these roles. The name of our training organisation is not that important, what is important is to ensure we are provided with good quality training at a reasonable price. The merger will be finalised in late December. Other mergers are likely with the desire to create an Infrastructure ITO that may include InfraTrain and other primary industries. The board structure of MITO will change and be different to what we have been used to with EXITO. The needs of the extractive industry training will be the responsibility of the Sector Advisory Group that will more than likely take a different form to what they do now within EXITO. The Institute of Quarrying will keep our members informed of any changes that occur over the coming months and I'm sure MITO will also contact trainees and companies once the dust has settled.

Pike River Royal Commission

The Commission's report released 5 November 2012 comprised two volumes of information relating to the tragedy. A full copy of the report can be found at - http://pikeriver.royalcommission.govt.nz/Final-Report. Included in the report are 16 primary recommendations and as expected most of the recommendations effect underground operations, although down-stream effects may influence how quarries manage their Health & Safety. Changes have already occurred with the functions of the Department of Labour being transferred to the new multi-functional Ministry of Business, Innovation and Employment (MBIE) in July this year. Another recommendation suggested "The regulator should supervise the granting of mining qualifications to mining managers and workers."

'One of those useless English girls?'


This is the title of a chapter in "Profiles in Stone ..." our history book, written to honour our members who contributed greatly to the quarrying industry. Sadly Lady Diana Isaac passed away at home on 24 November 2012; she was an Honorary Fellow of the Institute of Quarrying NZ Inc. You will have to read the chapter on Lady Diana to understand why the title to the chapter come about. I would like to summarise Lady Diana's contribution to the Institute. In 1990 Lady Diana presented the Jim Macdonald Lecture to many branches throughout the country with a paper that addressed the Restoration and Rehabilitation of a depleted gravel pit in Harwood, Christchurch to form what we know today as Peacock Springs. In 1995 she presented a paper at the Auckland conference titled "Peacock Springs - a study in Conservation - Where the Commercial and Wildlife are Complimentary". In 1996 she become an Honorary Fellow of the institute. She also presented another paper at the 2006 Christchurch conference "Lady Diana – her life in Quarrying"


Lady Diana Isaac will probably be remembered as a conservationist and businesswomen who developed Peacock Springs, although as she suggested in an article in the Contractor magazine in 2009 titled "Out of India" – "It was quarrying that gave rise to the conservation"

Neil Clayton and Louise Foord were probably one of the last to write about Lady Diana in our history book, this confirms we have made the

right decision in commissioning the book, to record these stories before they are lost forever.

Mike Henderson has been in the quarrying industry since 1970 spending five years with the Drinkrow family business, Kaipara [back then it was known as Kaipara Excavators], a company involved in the earth moving business and the quarrying arm including explosives. Mike then held a role as Sales and Technical Manager for ICI Explosives NZ Ltd (now Orica) for 10years until 1985.

For another eight years he was an owner/operator [Explosives Consultancy Services] drill/blast contractor, and consultant to quarrying, mining and construction industries. Mike was also involved in marine operations in New Zealand, Samoa, and Fiji with marine construction works including dredging and rock protection.

Mike is a shareholder and Operations Director for RedBull, and also Project Manager for Redbull's South Island contracts with OceanaGold (including Macraes Open Pit, Reefton Open Pit and Frasers Underground). He has overseen the construction of a new emulsion plant and mobilisation of resources for the OceanaGold contract which started on 1 October 2012 – a contract for 50,000 tonnes of Bulk Explosives over five years, as well as detonators, packaged explosives and accessories for both open pit and underground.

Mike has been instrumental in the growth of the company, with his vast explosives experience, an ability to grow and nurture industry relationships and an ability to train and build a strong, loyal team of the best shotfirers in New Zealand.

Since 1997, Mike has been involved with the management and supervision of Red Bull Powder Company's day to day activities involved in blasting for the quarrying and construction industries in New Zealand and Pacific Islands. He is also a skilled industry trainer a role which takes patience, understanding and empathy. He does this not only in New Zealand, but also Fiji, Guam, Palau, and Samoa. He also is a trainer for the NZ Army

During the mid 1990's Mike joined the Institute of Quarrying and supported our local branch meetings whenever he was able. In 1998, when Bill Bond was Manager, he was so proud of his new resource at Holcim's Bombay Quarry that he invited our Auckland Branch to attend a field trip. Bill had also arranged to have Mike fly as many as wanted to around the quarry - a short 2-3 minutes flight in a helicopter - it's something we will remember for a long time.

In the early 2000's Mike served on the Auckland Branch committee, and a couple of years back he was one of the supporters who was there with Redbull Powder Company when an enthusiastic group resurrected the flagging Northland Branch; an occasion that drew wide support with some 83 in attendance. Mike has also attended the Waikato / Bay of Plenty Branch meetings whenever he has been in the area.

Mike's wife, Chris, together with members of the Redbull Powder Company team joined him in celebrating a well-deserved award. Because Blackwood's representative, Mike Rawson, was unable to be present, Les Ward was invited to make the presentation.


Thames Valley Quarrying, Contracting and Waste Management Company, HG Leach & Co, recently celebrated the purchase of NZ's first Metso LT200HPS tracked cone crusher with screen by hosting an open day with equipment supplier Mimico at the Company's Tirohia quarry, composting and sanitary landfill site.

"This machine adds extra flexibility and production options to our existing fleet of Metso mobile crushing equipment. With our increasing activity in mobile crushing contracting, it adds a further string to our bow which will help to meet our customers' requirements now and into the future" said the Company's Managing Director Eric Souchon. "With an immediate requirement to produce 2000 cu.m of drainage metal to complete the next stage of the lining of our landfill, it gives us an excellent opportunity to assess its abilities in an actual working environment and I am pleased to say that it is meeting expectations".

Around 60 visitors from literally Kaitaia to the Bluff and HG Leach staff were on site to get hands on with the machines working - a Metso LT105 jaw feeding the new HP200S cone and a Metso ST171 screen.


















