EXTRACTIVES UPDATE FEBRUARY 2022



1. MITO JOINS TE PÜKENGA WORK BASED LEARNING

On 1 January 2022, as part of the Government's Reform of Vocational Education, MITO's arranging training functions, people and processes transferred to Te Pūkenga Work Based Learning, a subsidiary of Te Pūkenga. MITO has joined three other transitional industry training organisations in Work Based Learning – Competenz, BCITO and Connexis, with more joining over 2022. Te Pūkenga is a new entity that has the 16 polytechnics operating as subsidiaries with Work Based Learning a 17th subsidiary.

It is expected that Te Pūkenga will release its operating model in mid-2022 which will outline how vocational education will be delivered from 1 January 2023. This will see the 16 polytechnic subsidiaries integrated into Te Pūkenga and all arranging training functions transitioned from transitional industry training organisations to Te Pūkenga and providers.

From 1 January, Verna Niao is the Director of MITO, replacing Janet Lane, Chief Executive. MITO continues to operate as a business division within Work Based Learning and continues the facilitation of work-based training for the extractives industry, and other industries.

We received a very positive response for the call for 2022 MITO Scholarship applications. Each applicant will be advised on the outcome of their application by Friday 18 February.

3. FREE TRAINING FEES!

- Safety Critical Explosives Knowledge (part of the CoC Supplementary Credit Programme).
